The Romeo-Washington-Bruce Parks and Recreation is accepting bids for the resurfacing an additional length added to the Washington Twp. Park Tennis/Pickleball Courts. Total. 140' x 115', see project diagram attached.

COURT BID

TENNIS/PICKLEBALL COURT Resurface and additional square footage – approx.when completed 140' x 115'.

- Remove and cut out areas around existing cracks over 1" clean & fill cracks under 1"
- Remove & replace in ground base tubes used for net poles (we will provide the new base tubes for installation)
- Excavate and construct additional asphalt pad on north end of existing court approx. addition 20' x 115'.
6" gravel 21AA with 2 coats of asphalt: 1 ½" level coat and 1 ½" overlay of tennis court mix, finished with color top coating.
- Resurface existing courts with 1 ½" overlay of tennis court mix & finished with color top coating (Green)
- Paint tennis & pickle ball regulation lines:
Tennis lines (White) Pickle Ball Line (Red)
- Clean up and removal of all debris.

FENCING BID (Optional)

FENCING Replace existing Tennis/Pickleball Fence

- TENNIS COURT FENCE: Remove and dispose of existing poles, fence and debris. Install new 10 ft black commercial grade poles and chain link on new layout, see diagram. 140' x 115' Please include one walk thru entry with and one 12' double gate.

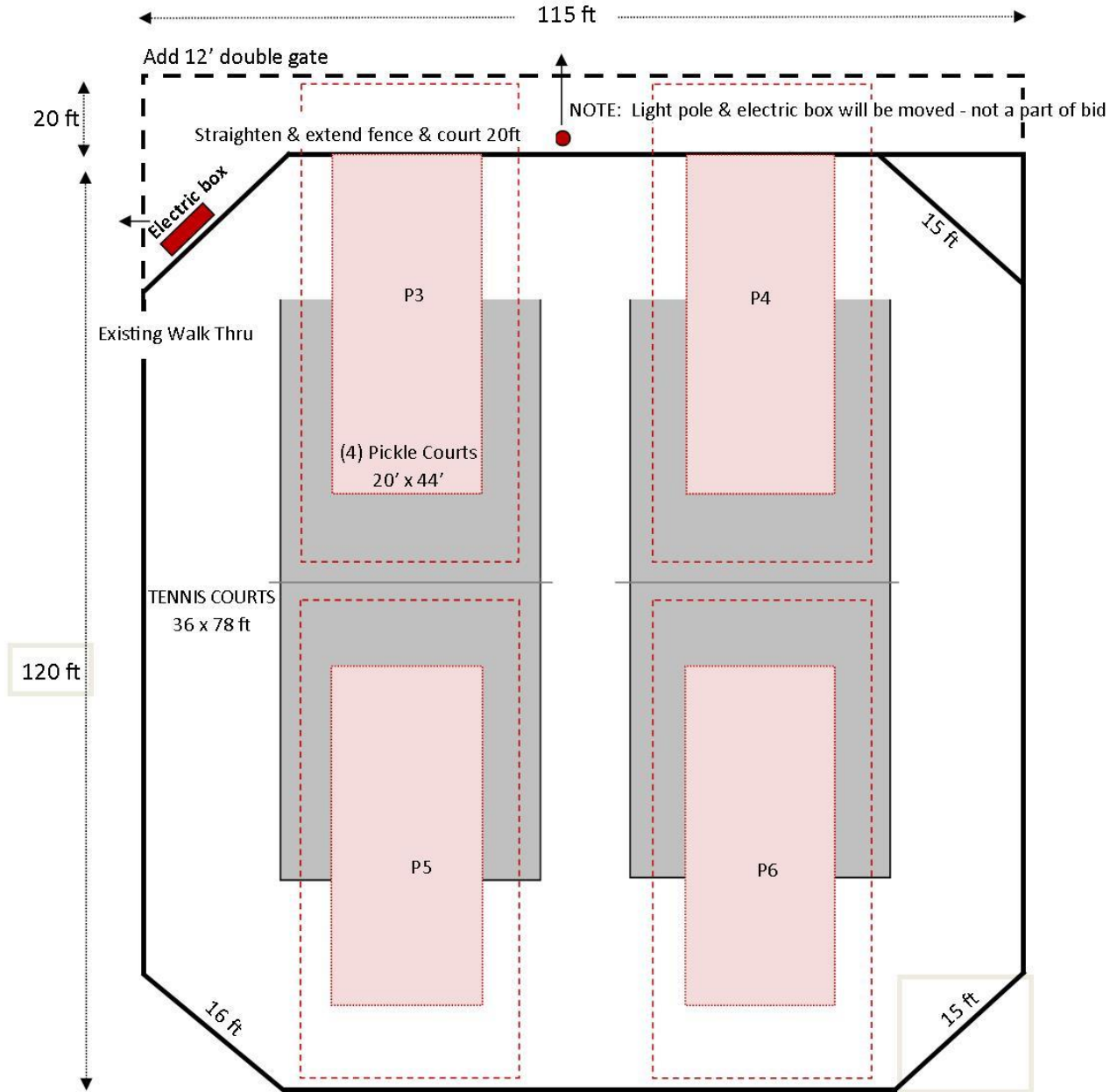
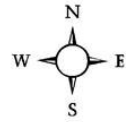
